To revoke the suspension, payment within 180 days of the due date may be accepted, subject to applicable penalties as specified by Food Authority. Where the fee remains unpaid beyond 180 days, the registration certificate shall be deemed cancelled and a fresh application for registration shall be required.
3. Any food business activity carried out during such suspension period shall be deemed non-compliant of the provision of the FSS Act, 2006 and the regulations shall attract subsequent action including penalty under the FSS Act, 2006
4. In the event of closure of business, the food business operator shall, within thirty days from the date of such closure, surrender the registration certificate by login into FSSAI's Food Safety Compliance System(<https://foscoss.fssai.gov.in>) with your user id and password.
